CHILD DEVELOPMENT CENTER, JEWISH BOARD PROGRAM MODEL UPDATE

Repair and upgrade work on our site's ventilation system which was necessary in order to ensure health and safety of students during Covid-19 pandemic has now been completed. The Child Development Center will begin our hybrid model on Tuesday, January 19 2021 as follows:

Cohort A (Blue Room, Green Room and Orange Room)

On site Monday/Tuesday and remote Wednesday/Thursday/Friday

Cohort B (Red Room, Purple Room and Yellow Room)

On site Thursday/Friday and remote Monday/Tuesday/Wednesday

Deep cleaning of site will occur on Wednesdays and Saturdays between cohorts.

Families will also have the option of electing a fully remote program.

Families will be allowed to move between hybrid and fully remote options, but must provide the school with 2 weeks' notice upon making a change.

In order to support children's emotional well being and to ensure a smooth transition, there will be an onsite phase in as indicated below.

5.5 HOUR SCHOOL DAY, WITH BUSING BOTH WAYS, IS NOW ESTABLISHED FOR EACH COHORT ON THEIR SCHEDULED ON SITE DAYS.

RELATED SERVICE PROVIDERS TREATING CHILDREN ON SITE WILL BEGIN ON MONDAY FEB. 1, AS PER EACH CHILD'S INDIVIDUAL THERAPY SCHEDULE.

Following the phase in, students will follow their cohort schedule for hybrid learning. Each cohort will be on site from 8:15- 1:45 on their scheduled days. Our robust remote learning model will continue for each cohort on their remote learning days.

In order to participate in the phase in and on site program, the following criteria must be observed:

1. All student admissions paperwork must be submitted and fully complete.
2. All students are required by the Dept. of Health to be vaccinated for flu in order to participate in school.
3. Visits to the site should be kept to a minimum and must be arranged in advance. Only one adult per child will be allowed on site at any given time.
4. All families must complete the Covid Screening App daily.  
<https://covidscreeningapp.jbfcs.org/>. Students/family member that do not get a green response are not permitted on site and children should not be put on the school bus.
5. Families must notify the school immediately if they do not pass the screening and/or if there is a positive or suspected case of COVID-19 in the household.
